“Show Your Metal”

Horse Barn Arts Center Gallery Exhibit January 7 — March 1, 2009

Open Call to Artists

The Horse Barn Arts Center invites you to participate in our January — February, 2009 Exhibit entitled “Show Your Metal.”

Concept: This exhibit of regional artists’ work will feature works in all media; the focus of the work is to be *metal*.

Fees: There are no fees to be in this show. You will be able to sell your work if you wish.

Images: You must provide JPG (or similar digital images) or quality photographs of your recent work to be considered for this exhibition. JPG’s must have a 96 dpi minimum resolution, and not be larger than 1 MB.

- You can email the information from the entry form to barn@siouxempireartscouncil.com.
- No phone call is necessary – if no email, mail form in. Email jpg images, no larger than 1 MB.
- Entries must be appropriately labeled with the artist’s name, address, telephone number, title, medium, dimensions, selling price or NFS, year completed, with a copy due to the Barn through email (preferably) or mail by Friday, December 18, 2009. (Use format on back of this form.)
- Entrants are responsible for transportation of their work to and from the Horse Barn. All Shipping or mailing charges to and from the Horse Barn are the responsibility of the submitting artist.
- The number of entries per artist is 2 pieces. If space becomes an issue, the HBAC will make final decisions on the number of pieces that can be reasonably exhibited for this show, depending on size.

TIMELINE:

- **Deadline to notify the HBAC of your participation is Friday, December 18, 2008.**
- **Exhibition dates: Wednesday, January 7 through Sunday, March 1, 2009.**
- **Work must be delivered to the Horse Barn on Monday, January 5, 2009, between the hours of 1:00 to 4:00 pm.**
- **Please note: If artwork is delivered after this deadline, it will not be installed.**
- **Artists’ Reception: Friday, January 9, 2009, 5:00 -- 8:00 pm. [Gallery talks at 6:30 pm.]**
- **Work must be picked up on Sunday, March 1, 2009, between 1:00 and 4:00 pm.**

ENTRY ELIGIBILITY:

- Artwork must be *original in concept, composition and execution, and created within the last two years.*
- Artwork must not be copied, in part or wholly from any published or copyrighted work.
- Artwork may not have been previously shown in the HBAC Loft Gallery, Portfolio Gallery or Gift shop.
- All two-dimensional artwork must be ready to hang – screw plates and wire are required -- SAWTOOTH HANGERS ARE NOT ALLOWED.
- A brief artist statement is requested. This can be about the work submitted and the technique used in its creation, or anything unique to the piece that you’d like to feature to our visitors. Email your statement as an attached word document, or include it in the body of your email. It will be included in a gallery guide for visitors.
- The Horse Barn Arts Center reserves the right to select artwork, and its decision is final. All artists exhibiting in the Horse Barn Arts Center must complete a Gallery File Card upon delivery of their artwork.

PUBLICITY/SALES:

- The Horse Barn Arts Center reserves the right to photograph any exhibited works and to use these photographs for promotional, educational, and/or publicity purposes.
- The Center will receive a 20% commission for any work sold from the exhibition. All prices must reflect this.
- **Liability:** Every reasonable precaution will be taken to assure the safety of submitted artwork. However, neither the Horse Barn Arts Center nor the Sioux Empire Arts Council nor personnel of these organizations will be responsible for loss or damage to artwork, however caused. Artists are responsible for insuring their own work. Pick up your work promptly.
- Submission of an entry into the exhibition indicates agreement by the artist to the conditions in this invitation.
